<p><b>STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED:</b> Floors may be slippery, use care to avoid falls. Contain and remove with inert absorbent, transfer to container for disposal. Keep spill out of municipal sewers and open bodies of water.</p> <p><b>PRECAUTIONS TO BE TAKEN IN HANDLING AND STORING:</b> Do not store above 120 F. Store large quantities only in buildings designed to comply with OSHA 1910.106. Keep closures tight and container upright to prevent leakage. Never use pressure to empty. Drum must not be washed out or used for other purposes. Use with adequate ventilation. <p><b>RESPIRATORY PROTECTION:</b> Use NIOSH approved respirator specified for protection against paint spray mist and sanding dust during spray application or sanding of dried paint.</p> <p><b>PROTECTIVE GLOVES:</b> Use gloves impervious to water and soap.</p> <p><b>OTHER PROTECTIVE CLOTHING OR EQUIPMENT:</b> Use protective outerwear and prevent prolonged skin contact with contaminated clothing.</p>	<p><b>VENTILATION:</b> Provide ventilation in volume and pattern to keep TLV and LEL below acceptable limits (see Sections II and IV). Open windows and doors to keep paint odor at minimum. Mechanical exhaust (fan) may be required in confined areas. These coatings may contain materials classified as nuisance particulates which may be present at hazardous levels only during sanding or abrading of the dried film. If no specific dusts are listed in Section II, the applicable limits for nuisance dusts are ACGIH TLV 10 mg/m<sup>3</sup> (total dust), OSHA PEL 15 m g/m<sup>3</sup> (total dust), 5 mg/m<sup>3</sup> (respirable fraction).</p> <p><b>EYE PROTECTION:</b> Safety eyewear including splashguards or side shields recommended.</p> <p><b>WORK/HYGIENIC PRACTICES:</b> Avoid breathing vapors and contact with skin.
